It is important for you to know changes that may affect your chorus or quartet. The links in this memo will connect you with the current Traffic Patterns and diagrams of the venues.

A virtual contest is different than an "in person" contest, and the Regional Management Team and our contest team have made every effort to give everyone the opportunity to perform on an equal basis and keep our members as safe as possible from the Covid 19 virus. We welcome all of you to come early and support the quartet and chorus contests. When you arrive you will go through the Covid Check-in and get a hand- stamp (washable ink) that will

allow you to come and go quickly. You can leave the facility and pass quickly through the performers check-in when it's time for you to perform.

## A Change!!

The Team agreed to offer an option for every chorus. They can follow the Traffic Pattern schedule and return to the Ready Room after "Stage Time" or remain on the stage after "Stage Time" and, when the videographer is ready, perform their contest songs. Please notify Joanna if you choose to stay on the risers.

This modification will not change the time schedule in the current Traffic Pattern. The Traffic Pattern has set times that take into consideration the amount of outside light that could affect the videography.

### **New Information!**

- Food is NOT allowed in any of the facilities. Beverages must be in contained/closed holders (not in cups).

- Directors: Nod to the camera/videographer when you are ready for the camera to start.
- You will have an escort through the Traffic Pattern
- Leave personal items in the bag(s) provided in the warm-up room. There will be an attendant. Please pick your things up as quickly as possible after your performance

# **Chorus and Quartet Briefing**

Since we will not all be together this year, I will do a short briefing with each competitor at the beginning of their warm-up.

Choruses should also bring with them, the List of Competing Members that was submitted to Joanna Davis. Any member who is on the list that will not be performing, should be struck through and any member who was not on the list that now will be performing should be added to the bottom of the list. Also make sure that the number of competitors on the top of members on the top of the form matches the number of members who are actually on stage.

## **Risers**

We had concerns from several chorus directors that it would not be fair for chorus competitors to use risers that were used regularly by another competing chorus, so we have provided every chorus competitor time on the risers before they perform. You will return to the Ready Room to make final adjustments to hair, makeup, costume, etc. before you take the stage for your performance.

## Using Parody

If you are going to sing a parody, send the lyrics to Joanna, <u>1983mjdavis@gmail.com</u> She will give them to the Panel Secretary.

Using parody has been challenging this year, and International has sent these instructions for anyone who is using parody this year.

To alleviate any confusion at your upcoming regional competition, please review the below instructions if you are performing parody lyrics:

• Remember, the original non-parody arrangement must be listed as admissible in the Song Evaluation database, linked

- You must also have an admissible rating assessment by the Song Assessment Committee for your parody lyrics.
- IMPORTANT Take a copy of the email you received from the Song Assessment Committee, showing the admissible rating of your parody lyrics, and include it with the song list you turn into the panel chair at your regional competition.

### **Competitor Video and Photos Information**

After the virtual performance at the Region 12 Convention on May 28<sup>th</sup>, Randy will send the performance videos to the competitors. International will send the scores and comments to the competitors after the Panel Chair announces the winning competitor at our Convention on May 28<sup>th</sup>. Photos will be taken at the end of your performance. They will be sent to the chorus or quartet contact person.

### **Withdrawals**

Should you find it necessary to withdraw from the competition, a written withdrawal notice (email is okay) must be sent to International Headquarters (<u>competition@sweetadelines.com</u>).

## **Announcement**

Once the competitor has had their 15 minutes of stage time, they can either move to the Ready Room for last minute preparations or remain on the risers to perform their contest songs for videotaping. For competitors who choose to go the Ready Room, just before the competitor is escorted to the stage, an announcement will be made to any audience members that photography or video recording is not allowed and cell phones and electronic devices should be silenced. For choruses who opt to stay on the stage this announcement will be made while they are on the stage.

From the Ready Room, the competitor will be escorted to the stage. Quartets will be held to the side, while choruses will take the risers. The competitor may take a pitch at this time.

Once the competitor is ready, they will signal toward the video camera that they are ready.

The Quartet announcement will likely be:

#### We are now recording – Silence Please!

WE ARE READY FOR CONTESTANT # FROM Chorus name(s) Quartet Name!

Quartets should start walking to center stage when the names of the chapters are announced.

The Chorus Announcement will likely be:

We are now recording – Silence Please

WE ARE READLY FOR CONTESTANT # FROM location UNDER THE DIRECTION OF Director's Name! Chorus Name!

It is up to the director to know when to move out.

When the videotaping ends, Joanna (standing beside the videographer), will lift her hand and count down with each finger, i.e., 5, 4, 3, 2, 1, and then the chorus can take their photo pose.
