If you are a Director, Team Coordinator/President, or member of a quartet that is considering competing, please read the 2022 Regional Competitor Information for Video Contest. It will provide important information and answer many of your questions.

# 2022 Regional Competitions for Video Contests

#### No entries will be accepted after the late entry deadline - no exceptions!

#### Song Assessment Required

This year all music used in competition MUST be assessed and determined Admissible prior to its performance on stage. There is a <u>Song Assessment Tool Database</u> you can check to determine if your songs and arrangements are listed as Admissible. Or you can submit your song information through the <u>Song Assessment Tool</u>. Any performance containing a song **NOT** rated Admissible will be immediately stopped, and the competitor will be **disqualified**.

The competitor entry forms now contain space for competitors to include the Song Title, Arranger and Date it was rated as Admissible. Fill out these forms with any and all songs that you intend to perform at regional contest. **ENTRY FORMS WILL NOT BE ACCEPTED IF THIS SECTION IS BLANK.** 

#### Official Inspection/Sound Check by Judging Panel

The Competition Team will conduct an inspection of the venue and sound check at each venue before the competition.

# **Open Division Contestants**

Contestants who wish to perform in the Open Division must check the appropriate box on the registration form that is sent to International.

Open Division contestants must fill out their Cue Sheet carefully. You must also check the boxes at the bottom of the page that ask if your performance begins and/or ends with spoken word. This is a timing issue for the Panel Secretaries, and deviation from what is included on their form will result in disqualification. Open Division competitors who are disqualified will receive their score sheets with the level scores removed due to disqualification.
