## Message from Housing Coordinator Amy Fleming

I'm sure we are all starting to look forward to our time to FINALLY be back at the Nugget Casino Resort in May. We continue to work with the resort to refine our procedures to make our time there run as smoothly as possible. Detailed information about housing will be available on the website in January and through your Chorus Housing Chair. In the meantime, a few things to keep in mind:

- There will be a slight increase to the base room and suite rates.
- Plan early if you will need a wheelchair or motorized cart. Information about reservations for this will be distributed in the next bulletin.
- The easiest way to handle the bill is for one person to settle with the hotel and for roommates to pay that person directly. The hotel can manage splits, but it is a tedious and very lengthy process.
- Rooms will be available to us in both towers. Suites are in both the Resort and Casino Towers. If you have a preference as to which tower you want to be housed, request this when making your reservation.
- All rooms in both towers now have a small fridge and a Keurig coffee maker. Only two K-cups are provided each day so you may want to bring additional cups with your own favorite flavor.
- There are NO microwaves in the rooms.
- Complimentary Wi-Fi, local calls, bottled water (2 per day), airport shuttle, atrium pool, fitness center, and self-parking are available.
- There is currently NO valet parking available but vehicles may be left in the valet area for 30 minutes to allow time to get checked in and drop luggage. Vehicles must then be moved to the surface lot or garage. Handicap parking is adjacent to the valet area.
- Self check-in kiosks are now available to help speed up the check-in process so be prepared to work with that technology and try to get questions answered in advance as it's likely less human help will be available.

## Please Read the **Competition Handbook**

#### When and Where is the Contest?

Region 12's next convention and competition will be held on May 4-7, 2023 at the Nugget Casino and Resort located at 1100 Nugget Ave Sparks, NV 89431. The Nugget Ballroom will be the room where the actual contest is held.

## How Do I Register My Group for Contest

When IHQ opens registration for Region 12, the Region will notify all choruses and quartets in the Region. The notification will contain links to the chorus and quartet competitor pages on the IHQ website, which will link to all resources and forms, including the entry form. **Note:** You must first log in as a member before attempting to access these pages.

These links will also be located on <u>Region 12's website</u>, under <u>Convention 2023</u> (you do not need to log in as a member to access) and they will also be in the next bulletin.

### What's a Division?

A Chorus or Quartet may choose to compete in one of three divisions. The following describes each division:

- 1. Evaluation Only
  - Must be performed onstage during a live event
  - Sing two competition songs or medleys
  - Performance should be not less than three minutes and not more than seven minutes in length
  - Will only receive written scores sheets with level scores only
  - Not eligible for medals or placement
  - Not eligible for Audience Choice Award
- 2. Open Division
  - Must be performed onstage during a live event

- Sing one competition song or medley and at least one other song or medley
- Performance should not exceed ten minutes in length
- The performance should be presented in an entertainment package with emcee material
- The package will be evaluated with comments written using the following criteria: Musicality, Unity, Planning, Creativity, and Audience Connection
- Not eligible for medals or placement
- Eligible for Audience Choice Award

#### 3. International Division

- Must be performed onstage during a live event
- Sing two competition songs or medleys
- Performance should not be less than three minutes and not more than seven minutes in length
- Will receive written score sheets with number scores
- Not eligible for Audience Choice Award

## Is There Any Other Way to Perform for Evaluation or Open Division?

Yes, a chorus or quartet may choose to submit a performance for Evaluation Only or Open Division package by video. Those choosing this option are required to pay the usual competition entry fee. The official panel evaluates the recordings prior to each regional competition.

#### Things to note:

- Submitting a video recording does not fulfill the requirement of choruses to compete every three years in order to maintain their charter
- The chorus or quartet will not be eligible for any prizes or awards
- The chorus or quartet submitting a video recording may not perform on the regional contest state for evaluation or placement in the same year

## How Does International Decide the Order of Appearance

The Competition Department at IHQ will conduct the drawing for Order of Appearance on 03/13/2023. For complete details on how the draw occurs, review the <a href="Competition Landbook">Competition Landbook</a>. Here are the basic rules:

- For each contest session the Evaluation Only registrations are separated and drawn first.
- All other registrations are drawn randomly after that.

- Any contestant that indicated on their registration form that they wish to perform first will be handled separately and inserted in the beginning of their chosen division.
- Once the draw has occurred, any late entry will be placed at the beginning of their division after contestants who opted to sing first.

The Order of Appearance will be sent to the Region and posted on Sweet Adelines website. The Region will post the Preliminary Order of appearance shortly after it is received. The Final Order of Appearance, that will include any corrections and late entries, will be posted approximately 15 days later.

## What Will the Stage Look Like?

The stage is 60' wide by 36' deep by 32" high. It is built of sixty-seven 4'x8' carpeted platforms supplied by the Nugget Hotel and Casino. The stage will be surrounded with rails for safety and black pipe and drape. On stage left, there will be a 4' wide, ADA compliant, ramp that will be used for all competitors to enter and exit the stage. On stage right, there will be a set of stairs with handrails which will only be used with permission from the Competition Coordinator. Only certain people will be granted permission to use these stairs (e.g.; dual chorus members who need to exit quickly to change costumes).

For the quartet contest, there will be five folding sections that will form a backdrop for the quartet (same as in the past several years). Two sections will be on stage right and

two sections will be on stage left and there will be a middle section. This set up will allow quartets to enter either from stage right or from the center.

For the chorus contest, there will be nine sets of 6' 3-step risers with the 6' back step. The middle riser section will be inverted. The outer most tips of the risers will be 12' from the edge of the stage. The measurement from the edge of the stage to the middle of the first riser row will be approximately 20'. A off-white choral shell will be placed behind the risers.

Additional black pipe and drape will be used to make entrances and hide the backstage area.

The stage will not have a curtain.

### What about Lights and Sound?

Quality theatrical sound and lighting will be provided.

For the quartet contest, two small diaphragm cardioid condenser microphones will be positioned as directed by IHQ in a document called Microphone and Sound System Guidelines.

If approved by the Panel Chair, there will be stage monitors.

Chorus microphones will be flown overhead.

Lighting will come from a truss hanging above the stage. There will be lights between the risers and the shell so that all chorus members are equally lighted. The Audio/Visual technicians will adhere to the requirements set by IHQ in the document called Regional Lighting Standards.

For Open Division Competitors, you can use up to three microphones; center stage microphone, stage-right microphone, and/or stage-left microphone. We will set these microphones up as you have indicated on the Open Division Cue Sheet, which is due to me 30 days prior to contest.

Depending on the number of attendees at the event, it is possible that there will be speakers half-way to the back of the ballroom to amplify the sound coming from the stage. These speakers must not interfere with the Judges, who are to hear only unamplified sound. The Panel Chair has the final say during the Official Inspection whether these speakers will be used or not.

#### Will the Audience be Able to See Us?

As in past years, there will be two large Jumbotron screens positioned at either side of the stage. The audience, wherever they are seated, will have a wonderful close-up view!!

## Do We Have to Worry About Copyright Clearance?

Yes, it is up to the competitors to obtain the appropriate licenses for their songs. IHQ is responsible for administering the copyright policies and procedures. ## Can We Sing a Song with Parody Lyrics?

Yes, but you must get permission from the owner of the copyright holder(s) and get clearance from IHQ. See documents on Copyright listed above. You must also submit your parody lyrics for approval. See the links at the bottom of this section regarding the Song Assessment Tool. Note: You will need to submit the parody lyrics and the email that you receive from IHQ approving the parody lyrics to me along with the Song Information Form prior to contest.

## Can My Friends and Family at Home See Us Perform?

Absolutely!!! Our webcast team will be set to provide a top-notch live broadcast from Sparks, Nevada directly to your loved one's most favorite video device! More details to come in future bulletins – so be on the lookout!

## Will Photographs Be Taken?

Yes! Our photographer for this contest is Jon Read. Jon has been our photographer in the past and we are looking forward to seeing his wonderful pictures again. He will take all quartet photos at the beginning of the pattern in a quartet photo room. Chorus photos will be taken on stage at the end of the chorus' performance. More information will be sent to competitors after the Final Order of Appearance has been published.

### Will Video Recordings Be Made Available to the Competitor?

The answer is yes, but since we have not yet selected our new Videographer, there are some details for the RCSC to work out. Keep a look out for our future communications for more information!

## I Use a Mobility Device, Can I Still Perform?

Absolutely, you can perform! Whether you wish to take your mobility device on stage with you or park it close to the bottom of the ramp or something in between, the

Competition Coordinator team will work with you to make sure you get your moment in the spotlight.

At a later date, we'll ask for more detail about people who will need to use mobility devices! Also, the hotel will rent scooters, wheelchairs, or other devices – look for another article in this bulletin or the next one from the Housing Chair regarding how to rent a mobility device!

## I Sing in More Than 1 Chorus, Can I Perform with All My Choruses?

Yes, the Competition Coordinator team will work with all Dual Chorus members to make sure they can change their costumes and get back into the pattern in time to take the stage with their alternate chorus(es). There will be a Dual Member Changing area just off stage on stage-right. Most dual members will find that they have plenty of time to get off stage, change, and get back into the pattern. Occasionally, there will be some very quick turn arounds and we'll work with you to make it happen.

After the Final Order of Appearance has been published, an email will be sent out to Team Leaders and Directors asking if they have any dual members and which choruses they dual with. So if you are a competing dual member, let your team leaders and directors know – make their job easy!

## Are There Any Rules from International That I Should Know?

All the rules for competing can be found in the <u>Competition Handbook</u>. All competitors are encouraged to read this document prior to registering to compete. Below are just a few highlights:

- The 3 year competition requirement for choruses is currently suspended. In its place is a temporary policy stating that all choruses must compete either in 2022 or 2023 regionals. For 2022, video submissions were allowed to fulfill that competition requirement. There is no such stipulation for the 2023 competition season. This means that if a chorus did not compete in 2022 regionals, they must either compete in 2023 regionals or request a presidential waiver through their region's Education Coordinator. - All songs that are sung in any Sweet Adelines International contest must have received an "Admissible" rating prior to its performance. Parody lyrics must also be approved. The original arrangement of the song must be admissible before the parody lyrics can be approved.

**Important:** In the Song Assessment Database, if your song has been rated admissible, check for "**Yes: Caution**" or "**Yes: Note**". If the song has either one of these notations, click the link in the next column and read the notes added by the Song Assessment Committee.

- Quartets planning on competing in the 2023 Quartet Contest must register with IHQ by January 15, 2023
- In order to compete in Region 12, at least three members of the quartet must be members of a chorus in Region 12 or a Region 12 Chapter-at-Large member.
- A member may now compete in up to two different quartets during the same regional contest as long as they are in different competition divisions (e.g., one quartet is in the International Division and one quartet is in the Open Division). No more than two members per quartet may compete in the second quartet in the same regional contest.
- In the Open Division, only the four members of the quartet or the chorus director and performing members of the chorus may appear on stage. If, in the opinion of the Official Judging Panel, the presence of a non-singing member is a distraction and/or detracts from the musical performance; a penalty may result.
- Competitors may not change from Open Division to International Division or Evaluation Only, or vice versa, after the Final Order of Appearance

The registration packet that will be available in January and other bulletins and memos will have additional information on rules and procedures, so please read those documents thoroughly!

### Can We Post Our Performance On-line After Contest?

In previous years, IHQ has given its permission to post your performance only after you have been adjudicated. Last year, because we held a video contest, that meant you could not post your performance until weeks after you performed. We currently do not have any updated guidance from IHQ on this issue, so the assumption will be that you will be able to post your performance after the awards ceremony of the contest session. Refer to future bulletins and memos for any change to this guidance.
